



## Terms and Conditions

Purchase a qualifying Apple Computer, using Apple's Education Individual Pricing, and a qualifying iPod between May 26, 2010, and September 7, 2010, and receive up to S\$308 via rebate (subject to terms and conditions). Claims must be submitted within ninety (90) days of your purchase.
