(a) When software is designed to run on a system that has a keyboard, product functions shall be executable from a keyboard where the function itself or the result of performing a function can be discerned textually.	Partially supported	Many basic functions in iMovie can be operated from the keyboard. The heads up displays (HUDs) can be opened using keyboard shortcuts. In most dialog boxes, the form elements can be controlled from the keyboard.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer. (c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. The focus shall be programmatically exposed so that Assistive Technology can track focus and focus changes.	Partially supported	The focus in many dialog boxes can be detected.
(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to Assistive Technology. When an image represents a program element, the information conveyed by the image must also be available in text.	Partially Supported	Many buttons and controls include names and/or reflect their state. Non-sighted users would need assistance visually identifying the image in movie clips. Once the clip is initially identified, iMovie provides a means for the user to label clips so that future interaction does not require sighted assistance.

(e) When bitmap images are used to identify controls, status indicators, or other programmatic elements, the meaning assigned to those images shall be consistent throughout an application's performance.	Partially Supported	Most on-screen controls are correctly labeled or adjusted.

(h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.	n/a	
(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.	Partially Supported	Many on-screen controls are properly labeled and adjusted.
(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	Partially Supported	The Video Adjustments HUD can be used to adjust color and contrast properties.
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	Supported

Partially Supported	iMovie is compatible with magnification and custom-display alterations and is largely compatible with the VoiceOver screen reader. See 1194.21 (d).
(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.	Partially Supported	iMovie can be successfully operated by users who are visually impaired and rely on a screen magnifier or custom-display alterations.
(c) At least one mode of operation and information retrieval that does not require user hearing shall be provided, or support for Assistive Technology used by people who are deaf or hard of hearing shall be provided	Supported
