

## **One-Day Shopping Event 2017 Terms and Conditions**

Customers can receive an Apple Store Gift Card with the purchase of selected Apple products. Offer is valid at Apple Store locations, on the Apple website and by calling 133-622 for purchases on 24 November 2017, subject to the terms and conditions herein.
