Products must be purchased from the Canada Apple Online Store for Education Individuals, an Apple Retail Store in Canada, Canadian Apple Telesales, or an Apple Authorized Campus Store on the list at [www.apple.ca/buy/hied](http://www.apple.ca/buy/hied) (referred to as "Qualifying Locations"). Only purchases made in Canada are eligible. All shipments of qualifying products (defined below) must be made to an address in Canada.
