

One-day Shopping Event 2017 Terms and Conditions

Customers can receive an Apple Store Gift Card with the purchase of selected Apple products. Offer is valid at Apple Store locations, Apple Online Store and by calling 1-800-MY-APPLE for purchases on November 24, 2017, subject to the terms and conditions herein.

Promotional Period: The promotion runs on November 24, 2017 (the “**Promotional Period**”), in Canada (“**Qualified Country**”).
